RECOMMENDED CASH ACQUISITION OF HEIT BY DRAX BESS HOLDCO LIMITED ("DRAX BIDCO")

Earlier today, the board of directors of each of Drax Bidco and the Company announced that they have reached agreement on the terms of a recommended cash acquisition, pursuant to which Drax Bidco, a wholly-owned subsidiary undertaking of Drax Group plc, will acquire the entire issued ordinary share capital of the Company (the **"Acquisition**"). The Acquisition is intended to be effected by means of a scheme of arrangement under Part 26 of the Companies Act 2006.

In accordance with Rule 2.11 of the City Code on Takeovers and Mergers (the "**Code**"), please accept this letter as notification that a copy of the Rule 2.7 announcement setting out the terms of the Acquisition released to the Regulatory Information Service of the London Stock Exchange earlier today (the "**Announcement**") is available on the Company's website at <u>www.heitp.co.uk/investors/proposed-offer-from-drax</u>, so that it is readily available to you. This letter is not to be taken as a summary of the information in the Announcement and should not be regarded as a substitute for reading the Announcement in full.
